The account holder(s) hereby authorize(s) the Fund(s) and its redemption agent to honor check writing redemption requests presented in the above manner.

It is further agreed as follows:

1. Paydenfunds reserves the right to change, modify or terminate this agreement at any time upon notification mailed to the address of record for the account.
2. The account holder(s) agree(s) to examine all account statements and canceled drafts and notify the Fund(s) of any errors within 30 days after they are mailed to the account holder(s). Failure to do so shall preclude any claim against the Fund(s) or its redemption agent by reason of any unauthorized or missing signature or endorsement, alteration, error or forgery of any kind.
3. Redemption drafts cannot be used to close an account.
4. The Fund(s) may refuse to honor redemption drafts whenever the right of redemption has been suspended or postponed or whenever the account is otherwise impaired

In case of shares purchased by check, redemption drafts will not be redeemed for 15 days after Fund shares are purchased.

To pay the draft, shares are redeemed from your Fund account at the net asset value per share computed on the day the draft is presented to the Fund for payment.

A fee of \$20.00 may be imposed on your account if a draft is returned for any reason.
